





# ANUCA Membership – Terms & Conditions

## 1. About ANUCA

ANUCA (the ADHD and Neurodivergent Universal Coaching Alliance) is administered by the Universal Coaching Alliance (UCA). ANUCA provides professional membership, resources, community, and standards support for coaches and practitioners working in neurodiversity-informed practice.

By applying for ANUCA membership, you must be a UCA Member and agree to be bound by these Terms & Conditions.

## 2. Eligibility for Membership

ANUCA membership is open to individuals who:

- Are practising or training as coaches, supervisors, or related professionals
- Commit to ethical, inclusive, and neurodiversity-affirming practice
- Agree to uphold the professional standards and values of ANUCA and UCA

ANUCA reserves the right to decline or withdraw membership where eligibility criteria are not met or where conduct is deemed incompatible with ANUCA values.

## 3. Membership Application

- Membership applications are submitted via an online application form.
- All information provided must be accurate and complete.
- Submission of an application does not guarantee acceptance where approval is required.

## 4. Membership Fees & Payment

- ANUCA membership is charged as a **monthly recurring subscription**.
- Payments are processed securely via Stripe.
- By joining, you authorise ANUCA to take the agreed monthly fee automatically until cancellation.
- Membership fees are non-refundable except where required by law.

## 5. Subscription Management & Cancellation

- Membership continues on a rolling monthly basis
- You may cancel your subscription at any time by e-mailing [membership@universalcoachingalliance.org](mailto:membership@universalcoachingalliance.org)
- Cancellation stops future payments but does not trigger refunds for payments already made

- Access to ANUCA member benefits ends at the conclusion of the paid membership period

## 6. Member Benefits

ANUCA membership may include (subject to change):

- Access to member resources and professional development
- Invitations to events, forums, and community spaces
- Recognition as an ANUCA member
- Opportunities aligned with neurodiversity-informed coaching practice

Benefits may evolve over time to reflect best practice and member needs.

## 7. Professional Conduct & Ethics

Members are expected to:

- Act ethically, professionally, and inclusively
- Respect neurodiversity-affirming principles
- Avoid misrepresentation of qualifications, accreditation, or scope of practice
- Comply with applicable laws and professional standards

ANUCA reserves the right to suspend or terminate membership where conduct breaches these expectations.

## 8. Use of Membership & Branding

- Membership status must not be misrepresented
- ANUCA logos, titles, or references may only be used in accordance with published brand guidelines
- Membership does not imply certification, accreditation, or endorsement beyond what is explicitly stated

## 9. Data Protection & Privacy

- Personal data is processed in line with UK GDPR and applicable data protection legislation
- Data is used solely for membership administration, communication, and professional purposes
- Payment data is handled securely by Stripe and is not stored by ANUCA
